CHAIRMAN'S REPORT - John Grosse

I cannot believe how fast years go by. Another has past and again we are filled with praise for a year of magnificent achievement by Margaret and her team. I am sure that the first to agree with me will be the clients who attended sessions at the OKMT studio, Care Homes & Outreach Centres - individual and group sessions of music therapy or other musical experience, and not forgetting the parents and carers of those clients who also consequently gained benefit.

For nearly 25 years the Trust has been bringing the extraordinarily powerful therapeutic benefits of music to hundreds of people, young and old, in Twickenham, the wider area of West London and the Home Counties. From its start, with music therapy for just a few local children with autism, the Trust has developed massively in size and scope and continues to be innovative.

Music Club and **Music School** went ahead in leaps and bounds, or should I say in crochets and quavers, and new ground was covered by a choir for the parents of children with additional needs and the projects of **Music and Me**, **Music Therapy in Adoption** and **Art Therapy with OKMT** workshop. We are excited that the pilot project for young people with psychosis gives prospect of help where it is so desperately needed.

Progress of all these projects, as well as music therapy clinically applied for individual clients, wholly depend on funds being available and in a group that receives no State funding much reliance is placed upon the generosity of individuals, companies and grant giving bodies.

We offer our grateful thanks to those who have supported us this year, some on-going, some with repeat grants and some for the first time. BBC Children in Need continued to support Music Club and Music School for Special Needs was made possible by grants from St James Place Foundation, Hampton Fuel Allotment, The Stephen Clark Charitable Trust and The Mercers Company. Our great local friends of the Rotary Clubs of Twickenham and Kew Gardens were joined in their support by The Prince's Trust, The Waterloo Foundation, The Grey Court Trust and The Hospital Saturday Fund along with the growing group of 'Friends of the Trust' who give £40 a year, where possible augmented by Gift Aid. Thank you all so much.

We were pleased that clients could put some of the work 'on display' in Concerts so that well-wishers could see for themselves the results of their support. Music School students did a short performance for a BBC team who visited in June and then made their first public performance in a Summer concert in July followed by a Christmas concert in December in Hampton Hill when their choir and the parents choir performed to a full house. It was truly wonderful for all concerned – very well done everyone!

Our Director, Dr Margaret Lobo has a brilliant team and they never cease to produce amazing results. The MT professionals work with complete dedication to their clients and their calling and they are ably supported by the very small administrative group and volunteers that diligently control the paper work and still find time to make the applications that bring in the funds to keep everything going. All make superb efforts and we congratulate them for the great successes achieved.

I offer an enormous thank-you to the trustees, Director, therapists, staff and volunteers for all your efforts in making this another superb year.

Otakar Kraus Music Trust's Activities in 2013

The Otakar Kraus Music Trust was formed in 1990. It provides music therapy for children and adults who have physical, psychological, behavioural and emotional disabilities. Our mission is to ensure that everyone has access to affordable music therapy in order to improve their wellbeing and quality of life and reach their full potential. We are currently headquartered in Twickenham, Middlesex with outreach centres in West London and the Home counties.

The Otakar Kraus Music Trust is an independent, registered charity (No: 1009797). All its therapists are highly qualified practitioners and are members of the BAMT (British Association for Music Therapy) and HCPC (Health Care Professional Council). Otakar Kraus operates a published health and safety policy and a child protection policy.

The Trust provides bursaries for its clients who cannot afford its services, but does not receive any State funding. It relies on organisations which provide charitable funding and donations. It also holds self-funding events.

The Start Up of Music School

The success of the pilot projects in 2012 saw the creation of Music School for Special Needs Children and Young People. The brain child of one of the therapists at Otakar Kraus Music Trust, its purpose is to provide each student with focused attention that might not be available to them elsewhere. Unique in its teaching method and the only one of its kind in the U.K., it works towards preparing the students for performance and is intended to provide grounding necessary for those ready to take music exams.

Another aim fulfilled was the choir created from Music OK and also a choir for the Parents of children with special needs. Both have been successful during the year and their next goal is producing CD's.

Other Projects

Music & Me for Parents/carers with Toddlers and Music Therapy in Adoption were also successful pilot projects. There was also an Art Therapy with OKMT workshop for adults. All 3 can be available when funding and interest is forthcoming.

A Taster and pilot project for the Early Intervention Service in Hounslow for young people with psychosis. The goal is to integrate this group with Music School.

Music Club continues to be supported by BBC Children in Need.

Events in the Year (to raise funds and awareness)

CBB's came to visit in June and some of the Music School students did a short performance for them

Summer concert in July at the United Reformed Church in Twickenham – first public performance of Music School students

Dr Neelesh Pramod Korde from Goa, India gave a talk at the beginning of December on the role of sound in influencing the process of the formation of the human body

Christmas concert in December at St. James's Church in Hampton Hill. Music School students' choir and the parents' choir performed to a full house

The Music Therapy Trust (India) Annual Report 2012/13 for OKMT

The Music Therapy Trust is a registered Indian charity set up in 2005 by Dr. Margaret Lobo. The Trust set up a centre of excellence in New Delhi where we run a **Postgraduate Diploma Course in Music Therapy** training Indian and Nepalese musicians. After qualification, the graduates receive financial help and support to establish community-based music therapy projects in hospitals, health centres, schools and orphanages with clients who have physical and mental challenges as well as patients with cancer and other life-threatening illnesses. Since our inception we have helped over **5,000** disadvantaged children and adults through music therapy.

Aims and Achievements:

One of our main achievements is to provide skills training, employment and career development for local Indian musicians giving them an internationally recognised qualification enabling them to support themselves and their families. For students from areas of poverty and trauma too poor to pay for our one year postgraduate diploma in clinical music therapy course, we provide scholarships. Once qualified, these therapists are provided with financial and moral support to help them establish community-based music therapy projects in both urban and rural areas, working at hospitals, health centres, schools and orphanages, to benefit over 5,000 people. Our graduates receive ongoing professional development and are also trained to support community rehabilitation programmes and work with people facing trauma or those living in challenging and precarious conditions. **We are the first and only organisation in India to offer this educational training and support.** This is a long-term, sustainable project which aims to establish music therapy as a fully-recognised clinical profession in India.

Future Plans:

We aspire to provide music therapy to people all over India by opening more music therapy centres and establishing partnerships with other organizations to reach out especially to those in challenging situations – those with learning, physical, and emotional difficulties and those who are socially and economically marginalized.

An upcoming plan for TMTT is to expand our clinics both in Delhi and Gurgaon to provide **blended therapies** under one roof. These will include speech therapy, art therapy, play therapy, drama and dance therapy, which will allow clients to easily access different therapies as recommended by their physicians. We have drawn up a blueprint modeled on such clinics both in India and abroad. This will expand gradually as it involves huge financial and logistic challenges. The momentum of the initial clinic will also be a deciding factor on the expansion and search to involve other interested funders. Such a clinic will cater to a large population while maintaining global standards.

Our future plans include and are not limited to:-

- Supporting individuals irrespective of age, disabilities, impairment, health or capacity to live independently in the community and reach their full potential.
- Enabling individuals to get their voice heard, to understand their rights and to access the services they need.
- Enabling individuals to have their say about key issues that impact their lives.
- Opportunities for disabled and older people to engage in activities e.g. Music, singing together in a choir, Art, photography, drama, theatre workshops.

The Music Therapy Trust Nepal (TMTTN) Annual Report 2012.2013 for OKMT

TMTTN is the first institution to offer *Clinical Music Therapy* in Nepal. Established as a non-profit making organization in 2010, TMTTN, (under the umbrella of the Otakar Kraus Music Trust, UK), presently offers clinical services to diverse centres and organizations in the wider Kathmandu area. Clinical Music Therapists work with both children and adults who have physical and/or developmental delays and disabilities or mental health problems.

TMTTN also liaises with the media and runs workshops for parents, special educators, and professional organizations, thereby promoting the use of music as a therapeutic tool, and raising awareness about special needs & mental health. The therapists receive professional supervision from a Music Therapist from the UK and on-going development and guidance from The Music Therapy Trust (India) on a regular basis.

Achievements

International Folk Music Film Festival

A documentary film was made on the music therapy work introduced by TMTTN and shown at the International Folk Music Film Festival in Kathmandu on 23th November 2012. Conference about child rights in cooperation with CWISH

In this conference on 23rd of March 2013, several stakeholders (schools, orphanages and organisations for child rights) came together to discuss child rights in Nepal. TMTTN participated with the purpose of achieving more contacts to set up workshops and to start its awareness raising program throughout the districts of Nepal. Resulting from these contacts, TMTTN was invited to the New Year's Reception of the Nepal Psychologist Association and an initial workshop has been conducted for the Nepali Psychotherapy Institute (see further).

New Year's Reception Nepal Psychologist Association

On the Nepal New Year's Eve (13th of April 2013), TMTTN was invited to give a presentation about their work and future plans. 'Going into more remote districts' was one of the topics and cooperation with Nepal Psychologist Association is thus intended. They were very enthusiast to work together with TMTTN in the future and to help spreading music therapy throughout Nepal.

West Kathmandu Rotary Club

On 26th January 2014, the TMTTN founder, Dr Margaret Lobo, and India Postgraduate Diploma in clinical music therapy course tutor from the UK, Ruth Oreschnick, and TMTTN qualified music therapists, Kedar Gandhari, Kendra Gandharba and Amrit Gandhari met with the West Kathmandu Rotary Club to discuss collaboration and fundraising opportunities to help build on the excellent work of the trust.

FUTURE PLANS:

Evaluation awareness raising project –Further to Salim Laher's meeting with the West Kathmandu Rotary Club in 2012 and with the Nepal music therapy team including Trustee Raj Kumar and subsequent to Margaret Lobo's presentation to the Rotary Club of West Kathmandu, a fundraising event was held at the Fulwell golf club on 2ndof June 2014. A joint enterprise proposal has been jointly coordinated by OKMT & Salim Laher with the Rotary Clubs of Kew and Twickenham, West Kathmandu, Nepal and Rotary International to raise funds for the following Well Care Centre in Nepal.

The awareness raising project, intended for three years has two main goals:

- 1. Demonstrate to those who work with the target groups how music can be used in a therapeutic way through the means of giving initial workshops followed by music therapy programs established to meet the need of each organisation concerned.
- 2. Awareness developing on special needs and mental health through the means of giving workshops and concerts, participating in fundraising events such as walkathons and emerging with other NGO's and institutions.

Apart from serving the community through its clinical work; organizing workshops and music therapy programs, it would be very opportune for the Trust to have its own premise in Kathmandu where it can set up a **Well Care Centre** to encompass all areas of art, health and education. Three outstanding Nepalese musicians were given scholarships to train at The Music Therapy Trust Post graduate Diploma course In Delhi and all are working full time to try to fill the need for this new work in Nepal. It is very difficult to send students to India as more scholarship funding is needed. Already two musicians are hoping to find support to start the PGD course in January 2015 and funding is paramount in order for them to be able to study and work in Delhi for one year, returning to Nepal once qualified to work with the team at TMTTN and continue to build on a standard of excellent service to the people of Nepal.

Final Conclusions

The constructing of workshops, music therapy programs and other awareness raising activities of TMTTN has resulted in a stable, secure foundation and standard of excellence for music therapy in Kathmandu and the wider environment. Our present three certified Nepalese music therapists and one Nepalese Administrator are continuing the activities with limited financial and people resources. Their salaries are partly provided by the organizations which are receiving music therapy, and partly by the Otakar Kraus Music Trust from the UK. Only with the help of funding from local organizations as well as from abroad can TMTTN become self-governing, thus enabling music therapy to continue to advance and meet the great need of the community.

A lot of work has already been done with hundreds of people (clients and professionals) reached and informed about music therapy. A lot of organizations are receiving music therapy, but it is necessary that on-going funding for the salaries of the therapists be provided. Some organizations have expressed a strong wish to receive further services, but due to the shortage of available funding and despite TMTTN keeping their costs low, the services have had to be put on hold or stopped until funding can be found. As the Trust is self-funding and receives no governmental support, the need for funding has to be explored at the outset when setting up new initiatives

As the Trust is concerned of the great need for this work in more remote areas of Nepal, its intention is to explore partnership development which can be used optimally to go further into these areas. This will be done over the next three years one funding is secured, starting from 2015 onwards.
